  - (i) The SPV shall be registered under the control of the Medical and Health Department as a private limited company to implement and administer the project APMEDTECH Zone.
  - (ii) The name of the SPV company may be “**Andhra Pradesh MedTech Zone Limited**” or such other name as approved by the Ministry of Corporate Affairs. The SPV shall be registered in Andhra Pradesh and initially the registered office shall be located in the premises of District Medical & Health Officer, Visakhapatnam.
  - (iii) The initial authorised share capital shall be Rs.1,00,000/-.
3. The following officers shall be subscribers and first directors of the Company
  - a) Dr. Smt. Poonam Malakondaiah, IAS, Principal Secretary (Health, Medical and Family Welfare), GoAP – Chairperson of the Board of Directors.

  - c) Sri K.V.Satyanaryana, IAS, Commissioner, Health and Family Welfare – Member Director
  - d) Sri B. Sridhar, IAS., Vice Chancellor & Managing Director, APIIC- GoAP - Member Director
  - e) Sri Jitendar Sharma, Advisor (Health & Med.Tech.), GoAP – Member Director
4. The expenses for the incorporation of the Company shall be borne by the Commissioner of Health & Family Welfare which will be reimbursed by the SPV after incorporation.
