On presentation of bills by the Accounts Officer, O/o Director of Medical Education, AP, Hyderabad on its admittance and passing the Pay and Accounts Officer, Hyderabad / Assistant Director, AP State Head Quarters, Treasury wing, O/o.DTA, A.P, Hyderabad shall credit the amount of Rs.25,00,00,000/- (Rupees Twenty five crores only) to the P.D.A/c of AP Med Tech Zone Visakhapatnam and intimate the fact to the Director of Medical Education, AP, Hyderabad, and the Chief Executive Officer, AP Med Tech Zone Visakhapatnam.

5. The amount deposited in the P.D. Account shall be utilized for the intended purpose, and shall not be deposited in any Bank by any authority.

6. The Director of Medical Education, AP, Hyderabad / the Chief Executive Officer, AP Med Tech Zone Visakhapatnam shall take necessary action in the matter, utilize the funds for the intended purpose duly following the prescribed procedure and furnish the utilization certificate / Statement of Expenditure for the amount sanctioned at Para – 1 above to Government.
