O R D E R:

In the reference 1<sup>st</sup> read above, the District Collector, Visakhapatnam has submitted a proposal for alienation of Government land to an total extent Ac.66.25 cents, i.e., Ac.10.00 cents in Sy.No.480/1 and Ac.56.25 cents in Sy.No.176 in Nadupuru Village, Pedagantyada Mandal, Visakhapatnam District in favour of Medical and Health Department for formation of Medical Technology Manufacturing Park on payment of Market Value @ Rs.20,00,000/- per acre to an extent Ac.10.00 cents in Sy.No.480/1 and Market Value @ Rs. 30,00,000/- per acre to an extent Ac.56.25 cents in Sy.No.176, subject to certain conditions.

2. In his reference 2<sup>nd</sup> read above, the Spl. C.S. & Chief Commissioner of Land Administration in his letter has stated that the proposal was placed before the APLMA in the meeting held on 13.06.2017 and the APLMA has resolved to recommend as proposed by the District Collector for alienation of Government land to an total extent Ac.66.25 cents, i.e., Ac.10.00 cents in Sy.No.480/1 and Ac.56.25 cents in Sy.No.176 in Nadupuru Village, Pedagantyada Mandal, Visakhapatnam District in favour of Medical and Health Department for formation of Medical Technology Manufacturing Park on payment of Market Value @ Rs.20,00,000/- per acre to an extent Ac.10.00 cents in Sy.No.480/1 and Market Value @ Rs.30,00,000/- per acre to an extent Ac.56.25 cents in Sy.No.176, subject to the following conditions in addition to the conditions under BSO-24 and G.O.Ms.No.571, Revenue (Assn.I) Dept., dated:14.09.2012.

3. Government after careful examination, hereby order for alienation of Government land to an total extent Ac.66.25 cents, i.e., Ac.10.00 cents in Sy.No.480/1 and Ac.56.25 cents in Sy.No.176 in Nadupuru Village, Pedagantyada Mandal, Visakhapatnam District in favour of Medical and Health Department for formation of Medical Technology Manufacturing Park on free of cost, subject to the following conditions in addition to the conditions under BSO-24 and G.O.Ms.No.571, Revenue (Assn.I) Dept., dated:14.09.2012.

1. The land shall be utilized for the purpose for which it is allotted within three years of the orders of alienation.
2. The alienee shall submit an annual report before 31<sup>st</sup> March on the progress of utilization to the District Collector.
3. The District Collector shall be authority to cancel and resume the land from the allottee for violation of conditions as well as for non-utilization of land.
4. The water bodies if any existing in the land should not be disturbed and should be allowed to continue their natural course.
5. The existing roads/ rastas should not be disturbed.
